Epoxy SURFACE PREPARATION

All surfaces to be coated should be clean, dry and free from contamination. Prior to paint application, all steel surfaces should be assessed and treated in accordance with ISO 8504:2000.

Oil or grease should be removed in accordance with SSPC-SP1 Solvent Cleaning.

Steel

Abrasive blast clean to a minimum of Sa2½ (ISO 8501-1:2007) or SSPC-SP6. If oxidation has occurred between blasting and application of Intergard 2509 the surface should be re-blasted to the specified visual standard. Surface defects revealed by the blast cleaning process should be ground, filled, or treated in the appropriate manner. A sharp, angular surface profile of 50 microns (2 mils) is recommended.

#### **Shop Primed Steelwork**

Weld seams and damaged areas should be abrasive blast cleaned to a minimum Sa2½ standard (ISO 8501-1:2007) or SSPC SP6. Where this is not practical, preparation to SSPC SP11 is acceptable.

Epoxy PRODUCT CHARACTERISTICS

Apply in good climatic conditions. The temperature of the surface to be coated must be at least 3°C (5°F) above the dew point.

At temperatures down to 5°C the addition of thinner may be required to aid application.

When applying Intergard 2509 by brush or roller, it may be necessary to apply multiple coats to achieve the required film build and uniform opacity.

Over-application of Intergard 2509 will extend both the minimum overcoating periods and handling times, and may be detrimental to long term overcoating properties.

The maximum overcoating interval will be dependent upon the integrity of the exposed film. A film of 75 microns (3 mils) dry film thickness will normally be overcoatable after 6-12 months exposure (depending upon the corrosivity of the environment) provided it is adequately cleaned and any areas of mechanical damage repaired.

In common with all epoxies, Intergard 2509 will chalk and discolour on exterior exposure.

Intergard 2509 is not designed for continuous water immersion.

Note: VOC values are typical and are provided for guidance purpose only. These may be subject to variation depending on factors such as differences in colour and normal manufacturing tolerances.

Low molecular weight reactive additives, which will form part of the film during normal ambient cure conditions, will also affect VOC values determined using EPA Method 24.
